

Francesca Quinn, PI Mystery

1 Backstory: A Year Ago

1. Therapist Chuck Westerly goes missing so the cops begin to investigate.
2. Frankie Quinn (Forensic Cop) and Wynton Rousseau (Cop) investigate.
 - (a) They find that Megan Quinn, Frankie's Step Mom, committed six murders.
 - (b) They begin going out secretly.
3. The following people resign from the police because of the Megan arrest.
 - (a) Jim Quinn. Chief of Police, Megan's husband, Frankie's father.
 - (b) Bill Duncan. He was keeping Megan updated on the case. (Don't know why.)
 - (c) Frankie Quinn. She becomes a PI.
4. Carl Wiesman was Frankie's HS sweetheart. He is a writer and is in town to cover the Megan trial.
5. During the trial Megan outs Frankie and Wyn's relationship.
6. After the trial Frankie resigns. Wyn thinks that Frankie is seeing Carl but Frankie says no and *You'll just have to trust me*. This jealousy causes Frankie and Wyn to break up. Then Frankie DOES start seeing Carl and they get engaged.

2 Current Day

1. Carl writes a novel about the murder titled *Love, Murder*. Frankie does not like that Carl is writing a novel since because it says too much about her— including that she was in love with two men (Carl and Wyn).
2. Carl fires his agent Pam since he thinks that she passed up an opp to be published by a big publishing house. She says that's not true.
3. Wyn begins dating Sally. Not clear how serious this is.
4. Bill Duncan goes to work for Kara McRae who is Carl's ex-wife.
5. There is a birthday party for Carl. He is killed that night
6. Frankie wears the bracelet that Wyn(?) gave her, showing she is still in love with him.
7. Frankie and Wyn and Beatrice interview Kara (Carl's ex-wife) to see if she has an alibi. Her alibi is her chief of security, Bill Duncan.
8. Frankie interviews Pam Getbaum (Carl's ex-agent). She will make a mint off of Carl's death since she was not officially fired yet. She seems to have no problem telling Frankie this.
9. Frankie interviews Christopher Bell (Carl's Protege). We haven't seen this yet.

3 Characters Who are Law Enforcement

1. *Frankie Quinn* Did forensics for the cops, and now is a PI.
2. *Jim Quinn* Frankie's Father. He was chief of police but resigned after his wife Megan was arrested for 6 murders.
3. *Det. Wyn Rousseau* Helped Frankie find out the killer was Megan. Is now on the Carl-murder case despite the conflict of interest that Carl was the fiance of his ex-girlfriend.
4. *Det. Beatrice Knudsen* Possibly brought into replace Jim Quinn. Is in charge of the Carl-murder investigation.
5. *Det. Ella Huntsman* Minneapolis Police Dept so helps Wyn and Beatrice when they need to interview Kara McRae in Minneapolis.
6. *Office Tommy Wiggins*

4 Other Characters

1. *Bill Duncan* (Black) Resigned after the Megan trial. He had been giving her information (we don't know why). Works for Kara McRae now.
2. *Sally Gibson* Wyn dated her once. Might date her again. She is either a waitress in, or runs, the coffee shop.
3. *Kara McRae* Carl's ex-wife. She claims she didn't know who Frankie was or that Carl was engaged.
4. *Pam Gelbaum* Carl's ex-agent. Not official yet so she will do well from his death.
5. *Christopher Bell* Carl's protege. Was at the Bday party. He's a suspect but I don't know his motive.
6. *Megan Quinn* She was Frankie and Carl's English teacher in HS. She married Jim Quinn and became Frankie's Stepmom. She killed 6 people before the story began.
7. *The Sandman* A thief who steals from people's houses when they are asleep but also takes personal photos.
8. *Harlan Trent* A guard at the prison where Megan is jailed.
9. *Mickey Cole*

10. *Sheryl Wiesman* Carl's sister. She hires Frankie, though Frankie was already working on the case.
11. *Megan Quinn* She was Frankie and Carl's English teacher in HS. She married Jim Quinn and became Frankie's Stepmom. She killed 6 people before the story began.
